

In spite of losses incurred by farmers over the last 6 years, the area of land where potatoes are cultivated in Bangladesh has been gradually increasing over the last 10 years.

## Potato production shows a lot of potential for income growth for farmers.

Currently Bangladesh produces around 11 million metric tons of potatoes annually, of which 4 million are exportable surpluses. However farmers are not able to reap the full benefits of this surplus due to limited cold storage capacity (only 23% of potatoes make it to storage), the absence of standard phyto-sanitary labs and a lack of good agricultural practices among growers.

In response to this, the Bangladesh Potato Exporters Association (BPEA), Sara Bangla Krishak Society (SBKS), the Department of Agricultural Extension (DAE) and the MMI-Bangladesh A2F+ project of FAO jointly organized '**Meet the Exporters**'. The overarching aim of the event was to find ways to ensure better prices for potato growers, by:

- understanding the demands of exporters in terms of variety, size and grade, as well as international standards and production practices;
- exploring opportunities for potato export and joint investment in good agricultural practices, and;
- connecting potato growers directly with exporters.

Following a robust, open discussion, all participants unanimously agreed that potato export is the only viable solution to absorb surpluses. In order for it to work effectively, however, it needs holistic investment from farm to fork. This investment must include education on *good agricultural practices*, establishment of accredited *phyto-sanitary testing labs to ensure food safety* and the establishment of *cold storage facilities* to keep potato surpluses from spoiling as they wait to be sold.



FAO, MMI producer organizations, BPEA, the Plant Quarantine Wing (Export) and the Field Service Wing of DAE all agreed to come together for this purpose.
- 2. Ethical and safe potato production practices were established.
- 3. Potato exporters and growers built relationships and even went as far as placing orders.
